General Information

- All applications should be submitted to the secretariat at info@ehpm.org.
- All applications are then presented to the EHPM board for approval.
- All application forms must be signed and dated by a person authorised to enter into agreement with EHPM.
- Membership fees are based on the period January-December of each calendar year. Members that wish to terminate their membership must do so on or before 31 December by communicating with the EHPM secretariat. Failure to do so will result in the member being liable for a full membership fee in the following year.
- The terms and conditions for membership are detailed clearly in this application form. In signing this form, all applicants commit unequivocally to respecting these terms and conditions and respecting EHPM's statutes in their current form or any subsequent amended form.

Key Terms and Conditions

1. Category 1 or 2 affiliate members of EHPM cannot use EHPM membership (the use of the EHPM logo for example) in marketing materials to convey the impression that EHPM is endorsing specific products or services or use their membership in any way to seek to gain advantage vis a vis companies that may be members of EHPM through national associations.
2. The EHPM board can suspend or revoke membership of any category 1 or 2 Associate member that it considers to be in violation of point 1.
3. Conditions 1 and 2 do not preclude EHPM entering into a specific agreement with a category 2 associate member to develop a specific service to be provided to the food supplement industry which would be endorsed by EHPM.
4. In the event of non-payment of membership fees, the EHPM board can decide to suspend a member until its membership fee is paid in full.

² EHPM's membership fee for full and associated members is based on a percentage of the income of the association seeking to join in the most recently closed financial year. At present the percentage fee charged is 8%. This percentage can be adjusted annually by a decision of the EHPM board but any association that joins will be informed of any change in the percentage for the forthcoming year in advance and will have the opportunity to opt out of membership should it wish to do so by notifying the EHPM secretariat by email (info@ehpm.org) of their intention to resign before the end of the calendar year (31 December) in which they are already committed to membership.

³ EHPM's membership fee for Category 1 Affiliate Members is based on which band (out of a possible of 3) a company falls into based on its turnover. The fees linked to the 3 turnover bands can be adjusted annually by a decision of the EHPM board but any association that joins will be informed of any change in the fee for the forthcoming year in advance and will have the opportunity to opt out of membership should it wish to do so by notifying the EHPM secretariat by email (info@ehpm.org) of their intention to resign before the end of the calendar year (31 December) in which they are already committed to membership.
