Conditions for Membership

All applications are subject to EHPM Board approval

Affiliate Membership

- 1. Affiliate members cannot use EHPM membership in marketing to convey EHPM endorsement of company's products
- 2. Affiliate membership cannot be used to gain an advantage vis a vis companies that may be members of EHPM through national associations
- 3. The EHPM board can suspend or revoke membership if point 2 is violated.

EHPM Quality Accreditation System

Strategy

- Endorsement as a standard by the European Commission.
- Cooperate with a certification body to establish a system for certifying companies for compliance with the standards in the guide for a fee.







EHPM Quality Accreditation System

Challenges

- Ensuring the system was robust to critiques that certification was being provided with out ensuring compliance.
- Cooperate with a certification body to establish a system for certifying companies for compliance with the standards in the guide for a fee.
- Gaining Commission support

Opportunities

- A certification process could use the expertise of SYNADIET and BDIH based on their existing activity in the area.
- Attain EU funding to establish a proper auditing system as part of a self-regulation initiative.
- Possibility to establish a longterm sustainable source of income.
