MEET THE SPEAKERS

In the order of presentation:

Livia Menichetti

As EHPM Director General, Livia Menichetti is responsible for the planning, development and implementation of the public affairs and advocacy strategy of the EHPM. She manages the relations with European Institutions in order to secure EHPM's policy positions and priorities with key EU-level decision makers. Livia also manages the relations with the European Food Safety Authority and participates to events and meetings. She supervises the EHPM external communications and represents EHPM within European and international meetings and events. She is responsible for the daily management of the EHPM Secretariat in Brussels, including general administration and finances. She coordinates the EHPM Working Groups and Task Forces, Members' Meeting, General Assembly and other events. Thanks to her extensive experience in EU public and regulatory affairs, she provides assistance to EHPM Member Associations and Companies. Livia holds a Master's in International Politics and Diplomacy at the University of Padua and a Master's in European Studies co-organised by the University ULB in Brussels and the University of Padua.

Thomas Lochot

Thomas Lochot is Client & Pharmacy Consulting Services Lead at IQVIA Belux. IQVIA is a world leader in using data, technology, advanced analytics and human expertise to help customers drive healthcare and human health forward. Thomas holds a Master's in International Business and has worked in different consumer health companies in various marketing roles before joining IQVIA in 2020. Among other topics, this unit addresses ongoing dossiers relevant to the food supplements sector, such as the setting of maximum levels for vitamins and minerals.

Jonathan Griffith

Jonathan Griffith is the Managing Director and Quality Assurance Manager of the Natural Medicine Company Ltd, a licensed pharmaceutical wholesaler of health products in Ireland. He holds a Bachelor's Degree in Mental & Moral Science from Trinity College, Dublin. In 1986, he was a founding member of the Irish Health Product Manufacturers Association (now Irish Health Trade Association - IHTA) and acted as its General Secretary between 1986 and 1998. He was one of the Irish delegates to the European Scientific Co-Operative for Phytotherapy (ESCOP) between 1989 and 2006 and is an honorary member of the Irish Society of Homoeopaths. In addition to his specific expertise in the national and international regulatory affairs regarding the wholesaling of food, cosmetic and medicinal products in the EU, Jonathan has worked directly with many leading companies in the health product sector. He has been a member of the EHPM Board for over 20 years and chairs the EHPM Botanicals Working Group.

Martin Last

Martin Last is the new Director of the Health Food Manufacturers' Association (HFMA). HFMA is the voice of the UK's natural health industry since 1965, representing around 150 manufacturers and suppliers of natural health products. HFMA supports the interests of its members with regulators; promotes industry best practice for product quality and safety; and provides responsible information for consumers. Martin has been closely associated with the HFMA for over 25 years, as a long-standing member company and as a committed member of the HFMA Council. He has served as HFMA Chair and Vice-Chair, and he is an active member of the Association's Technical, Political Engagement and PR Committees. Martin also represents HFMA within EHPM and is currently Vice-Chair of the Board. He chairs the EHPM Probiotics and Regulatory & Quality Working Groups.

Penelope Viner

After a career in industry as General Manager of a company making licensed natural medicines, food supplements and cosmetics, Penny Viner spent 7 years as Director of the Health Food Manufacturers' Association (HFMA) and is now its President. Penny also chairs the UK Herbal Forum and is Secretary of the British Association of Homoeopathic Manufacturers. Previously, she was a Director of the UK branch of the European Food Law Association. She was a member of the British Pharmacopoeia Commission Expert Advisory Group on Herbal and Complementary Medicines and a member of the Ministerial Herbal Medicines and Practitioners Working Group. She is also an industry representative on the MHRA's Medicines Industry Liaison Group. Penny is Vice-Chair of the EHPM Botanicals and Regulatory & Quality Working Groups. She is also an independent consultant on food and medicines regulation.

Food Safety Authority of Ireland (FSAI)

The Food Safety Authority of Ireland (FSAI) was established under the Food Safety Authority of Ireland Act in 1998. The principal function of the FSAI is to protect consumers and raise compliance through partnership, science and food law enforcement. The FSAI is a statutory, independent and science-based body, dedicated to protecting public health and consumer interests in the area of food safety and hygiene. It is responsible for ensuring that food and food supplements produced, distributed or marketed in Ireland complies with food safety and hygiene standards, best practice codes and legal requirements. The FSAI is under the umbrella of the Irish Ministry for Health and has a 15-member Scientific Committee that assists and advises the FSAI Board. Therefore, decisions relating to food safety and hygiene take account of the latest and best scientific advice and information available.

Fréderique Henderickx

Fréderique Henderickx has been working for Normec Foodcare Quality Assurance Belgium since 2018, first as a Consultant and Regional Manager, and currently as Business Unit Director. Normec Foodcare is part of the Normec Group, active in the TICC industry (testing, inspection, certification and compliance). Over the years, Fréderique gained quality experience in mid-size food companies and in multinationals in Belgium, as well as in other countries where she held different positions in quality management. Food safety, compliance and people have always been her main drivers with continuous improvement as guiding principle.

Antonino Santoro

Antonino Santoro graduated in Chemistry from the University of Messina, in Italy. With a background in research and product development, Antonino served in management position for several years in a multinational pharmaceutical company and taught Regulatory Affairs at the University of Pavia, Italy. He is the author of several academic scientific publications and of some patents. Presently, he is an advisor in the pharmaceutical and nutraceutical field. Antonino has been a Board Member of FederSalus (now Integratori & Salute) since 2005 and has served as Vice-President for some years. He is a member of the EHPM Board since March 2013 and EHPM Chair since February 2021.

Rafael Pérez Berbejal

Rafael Pérez Berbejal joined the European Commission in 2002 and currently works in the Directorate-General for Health and Food Safety (DG SANTE). He is currently leading the novel food team in the Unit E.2 "Food Processing Technologies and Novel Foods".

Stella D'Amore is a seconded national expert from the Directorate-General for Competition, Consumer Affairs and Fraud Prevention in France. She joined the Unit E.2 of the DG SANTE in 2020 where she works in the area of novel foods and food contact materials.

Magdalini Selanikli

Magdalini Selanikli is a Regulatory Affairs & Quality Assurance expert in food supplements and cosmetics. She holds a Master's Degree in International Relations and Diplomacy from Leiden University and an LLM in International Legal Practice from the University of Law, London. Through her expertise in regulatory affairs, Magdalini is closely familiar with the impact of EU and national legislation for food supplement companies placing products on the market. In particular, she has considerable insight into the challenges faced by EU companies when trying to enter the national market in other Member States. Magdalini was elected to the EHPM Board in March 2013 and has served as Treasurer and Vice-Chair (current position). She is also a Board Member of EHPM's Greek member SESDI.

Claire Guignier

Claire Guignier manages the public affairs and communications of the French Food Supplement Association, SYNADIET.
